Official Rules

NO PURCHASE IS NECESSARY TO ENTER OR WIN.

1. **CONTEST TERM:** The Contest is open continuously from 12:00:01 a.m. Eastern Standard Time ("EST"), March 1, 2013 and through 11:59:59 p.m. EST, June 30, 2013 (the "Contest Promotion Period"). Sponsor's computer is the official time keeping device for the receipt of entries for the Contest.
2. **AGREEMENT TO OFFICIAL RULES:** By participating in the Contest, entrants (also referred to as "you" or "your") fully and unconditionally agree to and accept these Official Rules and the decisions of the Sponsor, which are final and binding in all matters related to the Contest.
3. **ELIGIBILITY:** The Contest is open only to legal residents over the age of majority (at the time of Contest entry) in the jurisdiction in which they reside. **THE CONTEST IS VOID IN THE CANADIAN PROVINCE OF QUEBEC, THE STATES OF RHODE ISLAND, MAINE, AND FLORIDA IN THE UNITED STATES OF AMERICA, PUERTO RICO, AND WHERE PROHIBITED BY LAW, RULE OR REGULATION.** Employees (including non-employee workers), representatives and agents of Corel Corporation, its subsidiaries and affiliates ("Corel" or "Sponsor"), any Contest administrator, Contest prize partners and/or Contest promotional partners, and their immediate families (spouse, parents, siblings, children, and those living in the same household) are ineligible to participate in the Contest. The Contest is subject to all local, federal, provincial, state and governmental laws, rules and regulations.

 - a. **ONLINE.** Eligible entrants may, after completing all required fields in the Contest registration form and acknowledging agreement to the Official Rules, upload (by clicking the "Submit" button) one (1) unique and original Contest design entry, per category, up to six (6) unique original designs total per person (during the Contest Promotion Period) created by the entrant: (1) using a free trial version of either CorelDRAW® X6 or Corel PHOTO-PAINT™ X6 products downloaded from the Website, or (2) using entrant's existing CorelDRAW® X6 or Corel PHOTO-PAINT™ X6 products purchased from Corel or an authorized Corel reseller, for any one or all of the following design categories:
 - i. Advertising/Specialty Graphics
 - ii. Vehicle Wraps
 - iii. Textile/Fashion Design
 - iv. General Illustration & Fine Art
 - v. Student
 - vi. Speed Drawing

All original Contest design entries except for the Speed Drawing category must be no larger than 50MB in size and submitted in either a .CDR (CorelDRAW® vector or bitmap file) or .CPT (Corel PHOTO-PAINT™ file) format with all fonts (in the actual Contest design) converted to curves. The entries to the Speed Drawing category must be posted publicly on YouTube with the tags "speed drawing, speed painting, CorelDRAW, Corel PHOTO-PAINT" and the link to the video must be provided when submitting the Contest registration form. All entries will be opened by Sponsor using CorelDRAW® Graphics Suite X6. If an entrant exceeds the maximum number of Contest entries allowed per category Sponsor, in its sole discretion, shall consider the last entry received in time for that particular category as the official Contest entry for that category and the excess entries shall be disqualified. Sponsor will not consider any entries that have previously been submitted in any other Corel design contests; all entries must be unique and created solely by entrant for this Contest. All Contest registration forms become the exclusive property of the Sponsor, and none will be acknowledged or returned. Any attempt by any entrant, or any individual acting on behalf of any entrant, to enter the Contest, or vote in the Contest (if applicable to this Contest), by using

robotic, repetitive, automatic, or programmed entry methods or agents (such as Contest entry services), multiple or different physical addresses, email addresses, identities, registrations and logins, or any other methods will void that entrant's Contest entries and that entrant may be disqualified, in Sponsor's sole discretion, from the Contest and any of the Sponsor's other promotions. In addition to the foregoing, and if the Contest has a voting component, no person may vote by proxy for any other person. Proof of sending or proof of submission will not be deemed to be proof of receipt of the Contest entry by Sponsor. Sponsor is not responsible for lost, late, incomplete, invalid, unintelligible, illegible, misdirected, or postage-due entries (except where allowed by local law), which will be disqualified. Entries that do not follow instructions posted on the Website page, that violate any term, section or provision of the Official Rules, or entries that contain any non-original material, in Sponsor's sole discretion, will be disqualified. Eligible Contest entries received by Sponsor during the Contest Promotion Period will be gathered and combined. There can be up to three (3) potential winners in each category, and one (1) overall grand prize winner from all combined entries will be selected. Entrants submitting an original CorelDRAW® X6 or Corel PHOTO-PAINT™ X6 Contest design entry, subject to these Official Rules, qualify for the prize categories identified in Section 7 below.
